OBJECTIVE: The scheme of Post Matric Scholarships has been universalized, a policy which is unparalleled in the Country. From being an exclusive programme for SCs, STs and a limited number of BCs, the scope of the scheme is currently broadened to cover all communities within the stipulated income limit. Government is sanctioning Post Matric Scholarships benefiting around 13-14 lakh students per year of Scheduled Castes (SC), Scheduled Tribes (ST), Backward Class (BC), Economically Backward Class (EBC), Minorities and Physically Challenged students in the State. The scheme enable the students from the weaker sections to have access to higher education including professional courses like Engineering, Medicine, Pharmacy, Management, Computer courses, etc. The scheme applies to all universities & its affiliated colleges whose admission process is regulated/administered by the State Government.

E-PASS ONLINE PORTAL: In order to ensure transparency & accountability, the sanction and disbursement of Post Matric Scholarships, is being implemented through the Online System (E-PASS PORTAL) to the students of SC, ST, BC, EBC, Minorities and Physically Challenged in all the Welfare departments under Direct Beneficiary Transfer (DBT) mode withAadhar linkage. Govt. have entrusted the job to CGG for smooth functioning of the system (Website: http://telanganaepass.cgg.gov.in).

INCOME LIMIT: The income for SC/ST students was enhanced to Rs.2.00 lakhs per annum (G.O.Ms.No.60 SW(Edn.2) Dept. 27-9-2011) and for BC, EBC/Minorites – Rs 1.50 lakhs in rural and Rs 2.00 lakhs in urban per annum.

SANCTION LETTER FREESHIP

Sub: Sanction of free ships for economical backward sanction to build career of students – Submission of Documents —Regarding.

With reference to your request, we are to inform that apply for the sanction of free ships schemes, the following terms and condition

- 1. Students availing scholarships are required to maintain a minimum of 70% aggregate across all semesters in order to continue to be eligible for scholarships.
- 2. Scholarship will be given in the form of Fee Concession
- 3. Only for engineering courses of B.tech shall be considered for determining eligibility for a scholarship.
- 4. In case of any disputes, the decision of the college is final and shall be binding on the student.
- Finance assistance committee introduces three free ship scheme, which are student welfare scheme 25% off tuition fee, student merit scheme 50% of tuition fee and Employee child scheme 50% off tuition fee.

For sanction of free ship, the following documents need to be submitted:

- a) Acceptance of the terms and conditions by signing on the copy of this sanction letter.
- b) Submit family of student annual income certificate
- c) Letter of undertaking by the student continue his/her studies
- d) Admission as management or spot
- e) Admission as management or spot
